1. Definition

The UAM Spanish Treebank is a collection of written texts held on computer and selected for use in language based research and development. This collection is assembled into consistent electronic format and enhanced with syntactic annotations by the Licenser.

2. Status of Licensee

Licensee confirmes that Licensee is an academic or educational institution.

3. Product

The UAM Spanish Treebank consists of 1,600 sentences of Spanish newspaper text, taken from the El País Digital and Compra Maestra. The corpus was annotated with parts-of-speech and syntactic structures in the Spanish Treebank project in the Universidad Autónoma de Madrid.

Licenser and Licensee recognize that the copyrights of original texts belong to the respective publishers, as mentioned in the Appendix.

All rights in and to the UAM Spanish Treebank, including copyright, which are not granted to the Licensee in this Agreement, are retained by the Laboratorio de Lingüística Informática of the Universidad Autónoma de Madrid and the Text Providers (see Appendix).

4. License

Licenser grants Licensee a non-exclusive license to use the UAM Spanish Treebank version 1.0. Licensee agrees

• to use the corpus only for non-commercial, non-profit research purposes;

- to make no changes to the corpus;
- and to acknowledge the use of the corpus in all publications reporting on results produced with the help of the UAM Spanish Treebank.

This license is granted by Licenser to Licensee free of charge.

You agree that the owner has the right to publicly identify you as a user/licensee of the UAM Spanish Treebank.

This Agreement and the appendix hereto embody the entire understanding between the parties relating to the subject matter hereof, and there are no terms or conditions hereof express or implied written or oral. This Agreement supersedes all prior oral or written representations, agreements, promises or other communications, concerning or relating to the subject matter of this Agreement.

Use of the corpus or use of data derived from the corpus for any commercial purposes requires explicit written agreement of Licenser.

5. Non-Disclosure and Requirement to Exercise Professional Care

The UAM Spanish Treebank will be held in confidence by Licensee. The Licensee shall not copy, publish, distribute or otherwise give access to any third party to the whole or any part of the UAM Spanish Treebank. The Licensee shall ensure that its employees understand and abide by this restriction and shall supervise their activities with respect to the corpus.

The Licensee agrees to keep the UAM Spanish Treebank in confidence and treat such Materials with at least the same degree of care that it treats its own most confidential information. The Licensee may not assign, transfer, lease, sell, rent, charge or otherwise encumber the UAM Spanish Treebank.

6. Termination

This Agreement will take effect from the date of signature and will continue until terminated either by Licensee or Licenser.

Licenser may terminate the agreement forthwith if the Licensee commits any material breach of this agreement or if the copyright holder raises an objection against the terms of the license agreement.

Licensee may terminate this agreement within 30 days of written notice. On termination howsoever caused, the Licensee shall erase all copies of the the UAM Spanish Treebank. Upon termination the Licensee shall erase, or otherwise destroy, all full and partial copies of the UAM Spanish Treebank. A duly authorized officer of the Licensee shall promptly verify in writing to the Laboratorio de Lingüística Informática of the Universidad Autónoma de Madrid that the Licensee has complied with this obligation.
